# THE INTERACTION BETWEEN THE MENTAL HEALTH ACT & THE MENTAL CAPACITY ACT

With the introduction of the Mental Capacity Act, mental health services face the challenge of working with two pieces of legislation that directly affect them and their clients. Admission to hospital and the provision of treatment that was formerly via just two routes (voluntary and the Mental Health Act) now has a third route through the Mental Capacity Act. In addition changes in the Mental Health Act increases the level of interaction between these two pieces of legislation.

Professionals will, for some clients, face a dilemma of which Act to choose to provide the most appropriate care and treatment. In other cases both Acts will be used simultaneously for the same client.

This course provides an opportunity to explore in detail the interaction and overlap between these two Acts and how services are affected.

Mental health NHS and local authority staff, inspectors and commissioners of services. Some prior understanding of both Acts is required.
